For your better understanding, Internal Affairs cases are rated against the following standards:

- *Unfounded:* The allegation is false or not factual.
- *Not Sustained:* The allegation can neither be proved nor disproved.
- *Exonerated:* The incident occurred; but was lawful or proper.
- *Sustained:* The allegation is found to be true.
- *Policy Failure:* The allegation is found to be true; however, a flaw in the department's policy caused the incident.
