PREFACE

This a resolution accepts a donation from Chevron Phillips Chemical Company - Cedar Bayou Plant Corporation in the amount of \$5,000 to support the City of Baytown Youth Advisory Committee (YAC) Program.

On March 24, 2005, the City Council approved the creation of the Youth Advisory Commission (YAC) to assist and advise the Council on city youth issues. The YAC consists of twenty-five (25) students between the ages of 14 and 18. The students must be in good academic standing with a public, private and/or home school and reside within the boundaries of the Goose Creek Consolidated Independent School District. The students are selected by staff and appointed by the Council for up to three (3), one-ear terms.

The YAC encourages leadership through volunteerism and community involvement, helps identify issues and concerns of the youth, and assists in the implementation and planning of youth activities in the community.
