

GOT AN ALARM PERMIT?

¿TIENES UN PERMISO DE ALARMA?

Effective December 15, 2020, PM AM Corporation (the "PM AM") began administering the City of Baytown's alarm systems permit program and the collection of associated alarm fees. Therefore, all annual permit applications, payments and false alarm fees will be handled by PM AM who can be reached via toll-free phone number 1-855-879-6963, via ground mail at P.O. Box 142225, Irving, TX 75014 or by visiting the new online alarm systems page at: <http://www.famspermit.com/Baytown>. This new online program will allow citizens 24-hour access to their alarm permit account where they can print their permits, make real-time changes to the account, and complete online payments.

A partir del 15 de diciembre de 2020, PM AM Corporation ("PM AM") comenzó a administrar el programa de permisos de sistemas de alarma de la Ciudad de Baytown al igual de el cobro de las tarifas asociadas con alarmas.
