Temporary Food Booth?

What is a Temporary Food Booth?



A special event, in which food is offered, operating up to 14 consecutive days in on location for the purpose of providing entertainment, promoting a business or a fundraiser.

When do I need to get a temporary food booth permit?

When an event is open to the public.

When is an event considered open to the public?

- persons other than members of the organization and family members can attend
- advertising event in newspapers, on the radio
- posted bulletins or mailed out flyers, tickets being sold to the public

What fees are associated with operating a temporary food booth?

There is a \$30.00 fee for each day of operation per booth along with a \$15 application fee if submitted at least two days prior to the first day of the event. The fee is doubled if permitted within 2 days prior to the event.

Itinerant Merchant

What is an itinerant merchant?

A person, as well as his agents and employees, who solicits, sells or offers for sale any goods, merchandise, or service, or exhibits goods or merchandise for sale or for the purpose of taking orders for the sale

When should I obtain an itinerant merchant permit?

When vending from or upon a truck or other vehicle, going from house to house or from place to place or remaining on any one property for a period less than one hour.

What fees are associated with an itinerant merchant permit?

A nonrefundable fee in the amount of \$15.00. License is good for 90 days from the date of issuance

What hours may I operate?

Between 9:00 a.m. and 7:00 p.m Monday Through Saturday. There shall be no vending on Sunday.



Open-Air Vendor

What is an open-air vendor?

A person, as well as his agents and employees, who solicits, sells or offers for sale any goods, merchandise, or service to the public, or exhibits goods or merchandise for sale or for the purpose of taking orders from the public for the sale.

When do I need to obtain an open-air vendor permit?

When remaining on any one property for a period of one hour or more.



What hours may I operate?

Open-air vendors may operate between the hours of 9:00 a.m. and 9:00 p.m

What fees are associated with operating as an open-air vendor?

A nonrefundable fee in the amount of \$100.00. License is good for 30 days from date issued.

Live Outdoor Exhibition

When do I need to obtain a live out-door permit?


When setting up or operating any live outdoor performance, exhibition, carnival or circus, within the city.

What fees are associated with operating a live outdoor exhibition?

A \$100.00 application fee and \$100.00 for each day of operation.

What are the distance requirements for operating a live outdoor exhibition?

No live outdoor performance, exhibition, carnival or circus shall be located less than 500 feet from property used as a residence, school, hospital or church except when held at said establishments.
